





RE: "Meet Value Options" Forums

Value Options, Inc. of Norfolk, Virginia has been awarded a five year, \$51.6 million contract to serve as the Administrative Services Organization (ASO) for Maryland's Public Mental Health System (PMHS), beginning on September 1, 2009.

Meetings have begun with representatives from Value Options, stakeholders, and our current vendor, MAPS-MD. I want to ensure everyone who has an interest in this change that MHA is doing everything possible to make this a seamless transition so no disruption in services occurs to the consumers or payment to providers. To this end, MHA plans to hold a series of meetings with providers and other stakeholders for input and training on Value Options' system. MHA will also convene a Transition Oversight Committee with representatives from the mental health stakeholder community to assure that the transition proceeds as planned.

The current toll-free number, for providers and consumers, 1-800-888-1965 will remain the same. Beginning September 1, 2009 Value Options will be operating this number, rather than MAPS-MD

As a part of this transition, MHA and Value Options will hold series of regional community meetings for providers and consumers to introduce the community to Value Options and answer questions that may arise.
