### **SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION (SAMSHA) DATA INFRASTRUCTURE GRANT DATA CAPTURE**

**March 28, 2012**

**The SAMSHA Data Infrastructure Grant requires states to report member-level data for National Outcome Measures (NOMS). The framework for this member-level data reporting involves demographic, clinical, and outcomes (results observed in individuals receiving services from the PMHS) of persons served by the MHA.**

**Collection of these measures will begin March 30, 2012.**

For new authorizations, all providers will be required to obtain additional required data for:

- For Adult members 18 years old and older:
  - “Highest Level of School completed?” Valid values are displayed in a dropdown box for selection.
