Provider Issues

- **Status of provider-specific over-time OMS testing and report availability – Herb Cromwell:** The OMS site is set to go live on May 30th. There will be a provider alert early next week on the dates for the webinars to navigate this.
- **Report on new MHA workgroup on EHRs and regulatory compliance – Herb Cromwell:** Daryl Plevy is scheduling another meeting and has asked the Inspector General's Office and the Attorney General's Office to participate. The date has not been set yet for this workgroup.
- **Anything new re: MHA instructions to VO concerning audits – Herb Cromwell:** Daryl stated there isn't anything new from MHA and that they may need to set up a workgroup for this topic.
- **VO Update on IntelligenceConnect report to access changed auths – Herb Cromwell:** Jamie Miller and Michael Schorr are following up on this.
- **Per Daryl, VO was working on a memo regarding GZ documentation requirements for Residential Crisis Services – Herb Cromwell:** This is a legislative audit issue and is tracked by the Inspector General's Office. Daryl is waiting on the new draft from the Inspector General.
- **Are there any updates from MHA/VO on recent agency-specific concerns, e.g. a care manager trying to limit RCS access; apparent glitches in RCS payments; one agency's nightmare with MA numbers when they tried to change a location? – Herb Cromwell:** The first issue has been taken care of and was a training issue.
- **Is MHA turning RRP auths over to VO? Is the work of the PRP Auth Workgroup over? – Herb Cromwell:** Yes, the auths will go to VO. VO is writing up a draft proposal for this. The details still

need to be worked out and Daryl suggested the possibility of a workgroup being set up if time allows.
