Provider Issues

- 1) DHMH submitting a planning grant to SAMHSA in connection with the Excellence in Mental Health Act and Certified Community Behavioral Health Clinics (we know Shannon McMahon and Gayle Jordan Randolph are on top of this).
 - Herb, thanked the department for assisting, the process is "going full speed ahead", and moving forward with a tight time frame.
- 2) Telemental health regs (were to be published soon in MD Register)
 - Daryl stated moving forward, still in the sign off process, regs posting July 10th. Once MA regs are finalized BHA will have own regs for acceptations and approve other services.
- 3) BHA's work with CMS on the upper payment limit issue affecting C&A therapy codes.
 - Daryl stated, fiscal year 13 is complete, and fiscal year 14 is still going through the process.
- 4) What consumers and providers can do if a consumer loses pharmacy access because of the United MCO's reduction in its pharmacy panel?
 - Per Rebecca, if anyone has any concerns, Consumers and or Providers, please refer the impacted member to the website. There is a group within Medicaid that provides follow up information.

- 5) Medicaid training for PRPS and ACT teams on use of DLA-20 assessment tool (understand a meeting was held recently with MTM)
 - Darryl stated, details are still under discussion, however once the details are narrowed down, the information will be sent out.

 - Daryl stated, no provisions for retro authorizations, Jarrell stated, Provider manual Chapter 10 has not been finalized as of yet, Provider alerts will highlight changes, expect more to come
